

# BLANKET BONDING

## Class A - No Deductible

Blanket bonding is being provided to Posts and Districts that would like to bond officers other than the Post Quartermaster. VFW National and VFW Department By-Laws require that each accountable officer be bonded with an indemnity company as surety in a sum at least equal to the amount of liquid assets for which, as far as can be anticipated, each officer may be accountable. To provide this coverage, arrangements have been made with CNA Surety Company to provide a blanket type bond to cover five (5) positions. Each position is covered in the amount of \$10,000 to limit requested. The limit amount is \$250,000.00. **Any Post with the amount over \$250,000.00 must contact Harris F.
