- In addition to the Commander, each Post shall be entitled to elect one Delegate for every 30 Members or fraction thereof.
- Up to a like number of Alternate Delegates may also be elected. The alternate Delegate shall have no vote unless called upon to act in the absence of an elected Delegate.
- All Delegates and Alternates must be elected at regular or special meeting of the Post to be held in the month of April. Their delegate election must be reported by submission of this report to Department Headquarters **no later than May 16th, 2020.**
- Members presenting themselves as Delegates or Alternates whose names do not appear on a properly submitted Delegate Election Report shall not be seated as Delegates and will have no vote at Convention.
- Upon receipt of this report, Department Headquarters will list the Delegate/Alternate for your Post and make their credentials available for pick up at the credentials check-in desk at the State Convention. Only a member that is listed on this form can pick up their credentials.
