- 1. <u>New 988 Veterans Crisis Hotline:</u> The VA announced veterans now have the option to **Dial 988 then Press 1** to connect with caring, qualified responders for 24/7 crisis assistance.
- 2. <u>District and Post Commanders:</u> Per Section 218 (a) (1) (g) of the Bylaws: Commander's must assure that the office of Quartermaster is bonded according to Section 703 of the Bylaws.

ALL BONDS EXPIRED AUGUST 31, 2022. MAKE SURE YOU HAVE SUBMITTED YOUR BOND AND PAYEMNT FOR YOUR NEW BOND.

- **3.** <u>Post Commanders:</u> Submit to the Department Adjutant a Quarterly Audit of Post finances and assets no later than 30 days after the end of the reporting Quarter. Effective September 1st -- you are late!!
- 4. <u>Post Commanders:</u> The Post Commander or their designated representative will attend all properly called District training, conventions, or meetings.
- 5. <u>Post Commanders:</u> Any Post owning property and/or operating any facility or business concern must maintain general liability insurance, including, if necessary or appropriate, liquor liability insurance in an amount of one million dollars (\$1,000,000.00). Such insurance must name, as additional insured's, the "National Veterans of Foreign Wars of the United States" and the "Department of Texas Veterans of Foreign Wars of the United States."
- 6. <u>Post Commanders:</u> If you are missing any of the three mandatory VPR's that are past due get them done and turned in.
